SOR III Treatment & Recovery Funding



What can be funded with SOR funds?

Virginia's State Opioid Response (SOR) grant funds are distributed as **Treatment**, **Recovery**, and **Prevention** funds. This document focuses only on treatment and recovery funds provided to CSBs. There are additional SOR-funded programs through the Department of Corrections and the Virginia Association of Recovery Residences which are not captured in this document and are using the REC-CAP assessment to track programmatic outcomes.

SOR III funds are to be used to support treatment and recovery activities to serve clients with opioid use disorder (OUD) and/or stimulant use disorder. "Activities" can include...
Services OR Staff members

SOR funding may be used to support services (supplies, space, medication, etc.) and/or staff members to implement these activities. Activities commonly funded by SOR or provided by staff funded by SOR include:

 MAT for OUD Detox services Individual treatment services (i.e., counseling, therapy, psychiatry, crisis support) Group treatment services (i.e., counseling or therapy groups) Intensive outpatient program services (IOP) Contingency management Residential treatment services Treatment wraparound services (i.e., case management, transportation and childcare for treatment appointments) 	 Services provided by a peer supporter, such as: Community outreach Warmline support Group support Individual support Peer support in an emergency department setting Peer support in a justice setting (e.g., jails, recovery courts) Community education or trainings from a peer Housing support (i.e., rapid re-housing, transitional housing, recovery housing) 	



Who should complete a GPRA?

Clients who are receiving any service (1) funded by SOR and/or (2) administered by staff members funded by SOR (partially or fully) should complete a GPRA, regardless of their behavioral health diagnoses.



Scenarios

Scenario	SOR Funding Action	GPRA Action
Service requires funding in order to operate to serve clients with OUD or stimulant use disorders.	Fund service using SOR (fully or partially).	Complete GPRA with clients receiving service (should have an OUD or stimulant use disorder).
Service requires new staff member in order to operate to serve clients with OUD or stimulant use disorders.	Fund staff using SOR (fully or partially).	Complete GPRA with any client working with new staff in any capacity (may or may not have an OUD or stimulant use disorder).
Service requires funding and/or new staff in order to operate but will not serve any clients with OUD or stimulant use disorders.	Do not fund using SOR dollars.	No action.
